The Imagine Hagerstown Street Festival takes place on Saturday, September 26, 11 am-8 pm, on South Potomac Street, Hagerstown, MD. With a full day of great music, delicious food and drink, and fun activities for people of all ages, we expect this to be an amazing day in downtown Hagerstown! We're looking for vendors who make unique, hand-crafted items to provide a great shopping experience for attendees.

Event Date:

- Saturday, September 26 – rain or shine

Event Location:

- South Potomac Street (between Washington and Antietam Streets)

Hours of Operation:

- 11 am-5 pm* or 11 am-8 pm

* Vendors who choose to end at 5, must be able to completely break down their set-up and vacate the site by 5:45 pm (prior to the 6 pm headliner band)

Vendor Fees:

- \$35 per one 10'x10' space from 11 am-5 pm
- \$50 per one 10'x10' space from 11 am-8 pm
- No refunds will be provided
- Please do not send any fees at this time. If accepted to vend, you will be asked to send a fee at that time to secure your booth space.

Items Accepted:

- Unique, handcrafted items
 - Bath & body
 - Packaged food/drink (not ready-to-eat); herbal goods
 - Jewelry
 - Clothes / Accessories / Handbags
 - Knit/Crochet/Yarn
 - Ceramics
 - Toys/Children's Products
 - Glass
 - Housewares
 - Paper Goods/Stationery
 - Pet items
 - Wood
 - Artwork (2D and 3D)

Items Not Accepted:

- Multi-level, direct sales products (eg, Scentsy, Lularoe)
- Mass-produced or imported items
- Ready-to-eat food or drink

Equipment, Electricity, Vendor Responsibilities:

- Vendors are responsible for bringing own tents, tables, chairs
- Electricity is limited; vendors must state on application if required
- All vendors are required to post Maryland Sales & Use Tax License at booth (more information below)
- Depending on product, vendors may be required to show evidence of insurance before being accepted to Festival; organizers will make this determination.
- In order to prevent multiple vendors from selling the same or similar items, Festival organizers may ask vendors to only sell some of the products listed on their application. Vendors are not permitted to sell items that are not listed on their application or that have not approved by Festival organizers.
- All vendors are required to sign hold harmless agreement (attached)

Deadlines:

- July 1st Applications Due
- August 1st Vendors notified of decision about acceptance into the Festival
- August 15th Deadline to confirm participation with booth payment

Criteria for Selection:

- Quality of product
- Photographs of good set-up and display
- Sustainable, eco-conscious packaging and manufacturing
- Social media/web presence
- Ability to promote own business
- Priority given to vendors from the 4-state area

How to apply for a Maryland State Sales and Use Tax License:

All businesses, regardless of whether incorporated or operating as a sole proprietor, are required have a Maryland Sales & Use tax account and may be required to collect Maryland state sales tax. The only exception is agricultural products sold by farmers, which are exempt from sales tax.

*To apply for a Sales and Use tax account, visit the Maryland Comptroller's Office, www.marylandtaxes.gov, click on the **SEARCH** field, and type **Maryland Combined Registration Online Application**; or phone 410-260-7980 or 800-638-2937.*

Your Sales and Use Tax license must be displayed at your booth.
